Accommodation reservations are made by the OC according to the rules (national quota). Only accommodation requests sent to the LOC by January 10, 2022 can be considered and confirmed. For reservations cancelled after the deadline, a cancellation fee of 100% of the incurred costs has to be paid by the respective NSA's.

If the NSA wishes to use and book another accommodation than the one Provided by the OC, they have to pay the actual costs, i.e. the OC will only reimburse the amount according to the rules.* *Unless they do not notify OC of their intent and other rooms are cancelled after deadline.

When making their own bookings, the NSA bear full responsibility for all details and agreements; the OC has to be informed of these bookings. Please note that all extras utilized in hotel must be paid by teams directly to hotel.

TRANSPORTATION

The OC will provide free shuttle service between the hotel and the venue. This service is available to officials and teams alike that do not have their own transportation. OC to provide ground transportation at no charge to NSA's if arriving/departing GBW during transport window. Transportation to and from other airports is the responsibility of the NSA.

PRIZE MONEY

Will be paid in USD immediately following 2nd competition on Saturday and after competition on Sunday to each winner.

COVID-19 CONSIDERATIONS

The OC in cooperation with the public health department of Dickinson County will be monitoring guidelines and measures that need to be applied to the Covid situation as it may change. All teams will be notified if exceptional measures are necessary.

Entry and Exit from the USA

All participants involved including NSA athletes, coaches and support staff, are responsible for their own entry and exit into and from the USA. Be sure you follow all guidelines provided by the US and your returning country. **YOU MUST NOTIFY OC PRIOR TO ARRIVAL IN THE US IF YOUR TEAM WILL REQUIRE ANY TESTING PRIOR TO DEPARTURE FOR RE-ENTRY TO HOME COUNTRY.**
